## GDPR Website Privacy Policy

### **Introduction**

This Privacy Policy (the "Policy") explains how [www.collen.com](http://www.collen.com), located at [www.collen.com](http://www.collen.com), collects, uses, and protects your personal data in accordance with the General Data Protection Regulation (GDPR).

### **Purpose**

The purpose of this Policy is to show we have appropriate security measures in place to prevent personal information from being accidentally lost or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

## **Who we are**

Collen Construction Limited ('Company') is a 'data controller' and gathers and uses certain information about you. This information is also used by our affiliated entities and group companies (our 'group companies') and so, in this notice, references to 'we' or 'us' mean the Company and our group companies.

We collect, use and are responsible for certain personal information about you. When we do so we are regulated under the [General Data Protection Regulation](#) (GDPR) which applies across the European Union (including Ireland) and we are responsible as 'controller' of that personal information for the purposes of those laws.

## **Our website**

### **How we use your personal**

**information** We *use* your personal

information to:

- Expediently manage ongoing business relationships with the firms which you as an individual represent;
- Market our services; and
- Comply with our legal and regulatory obligations

### **Whether information has to be provided by you, and if so why**

The provision of personal information is required from you to enable us to manage our business efficiently and effectively. We will inform you at the point of collecting information from you, whether you are required to provide the information to us.

### **How long your personal information will be kept**

- Personal information will be retained in accordance with our [Data Retention Policy](#) but generally your personal information will be held for 'the period we are required to retain this information by applicable Irish tax law (currently 6 years).

Reasons we can collect and use your personal information

We rely primarily on consent as the lawful basis on which we collect and use your personal data where you have agreed to explicitly consented to the use of your data in a specific way, or use is necessary in relation to a service or a contract that you have entered into either personally or as a representative of a corporate body. We also have legitimate interests (which you may object to) such as managing our business, conducting marketing activities and strategic planning.

### **Transfer of your information out of the EEA**

We do not transfer your personal information outside the European Economic Area (EEA).

### **Your Information rights including the right to object**

Under the GDPR you have a number of important rights free of charge. In summary, these include rights to:

- fair processing of information and transparency over how we use your personal information

- access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address
- require us to correct any mistakes in your information which we hold
- require the erasure of personal information concerning you in certain situations
- receive the personal information concerning you which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to a third party in certain situations
- object at any time to processing of personal information concerning you for direct marketing
- object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you
- object in certain other situations to our continued processing of your personal information
- otherwise restrict our processing of your personal information in certain circumstances
